MXC Capital Limited (AIM: MXCP), the technology focused merchant bank, announces that, pursuant to the extended share buyback programme (the "Programme") announced on 3 April 2017, on 12 June 2017 it purchased 588,223 ordinary shares of no par value each in the capital of the Company ("Ordinary Shares") at a price per Ordinary Share of 1.595 pence ("Buyback Shares").

It is intended that the Buyback Shares, along with any other Ordinary Shares purchased by the Company pursuant to the Programme, will be cancelled in due course. Until cancelled, the Buyback Shares will be held in treasury.

Following the purchase of the Buyback Shares, the total number of exercisable voting rights in the Company is 3,358,777,510 (excluding the 13,709,764 Ordinary Shares held in treasury). This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company.
