The First Sale and Purchase are therefore related party transactions for the purposes of AIM Rule 13 of the AIM Rules. The board of directors of MXC consider, having consulted with the Company's Nominated Adviser, Zeus Capital Limited, that the terms of the First Sale and Purchase were fair and reasonable insofar as shareholders are concerned.

Furthermore, on 3 August 2018 MXC also sold a further 2,046,776 Castleton Shares at a price of 101.5 pence per Castleton Share (the "Second Sale"). Following the First Sale and the Second Sale, MXC now holds 5,341,588 Castleton Shares, representing 6.65% of the issued share capital of Castleton. The proceeds of the Second Sale will be used in line with MXC's stated strategy of investing in technology companies.
